Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 12. Any further increase shall require prior approval of the Board subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	According to the land certificate submitted, 3 plots are acquired by the trust through sale deed and 1 plot through lease deed. The details of the lessor is not available in the land certificate, however the school has uploaded the lease agreement on the Mandatory Public Disclosure. The school should obtain revised land certificate with the details of lessor and submit the compliance within 3 months on SARAS portal.

3	The school has submitted an acknowledgement received from office of the cooperative society in place of society registration certificate. However, the society registration uploaded on the Mandatory Public Disclosure. The school should submit the certificate on SARAS portal.
4	The school should upload the renewed fire compliance certificate within 3 months on SARAS portal as the earlier certificate dated 31.01.2022 has expired.
5	The school should fix hand rails throughout the ramp at the entrance and construct the ramp to the second floor as per RPwD Act 2016 and submit the compliance through videography within 3 months on SARAS portal.
6	The school is required to make arrangement for toilets for male/female staff of the school and submit the compliance through videography within 3 months on SARAS portal.
7	The toilet for the CWSN on the ground floor is too small and narrow to allow for proper navigation by CWSN. The toilet should be constructed as per norms of RPwD Act and guidelines issued by the Board within 3 months and compliance submitted on SARAS with videography.
8	The school shall ensure the training of its teachers with CoE Bengaluru within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of student class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded on the SARAS portal. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye-Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE website i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity/activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
